M.Phil. REGULATIONS (INTEGRATED STREAM - 2018)

(w.e.f. the Academic Year 2018-2019)

1.0 TITLE AND COMMENCEMENT

- 1.1 These regulations shall be called the Master of Philosophy (M.Phil) Regulations, 2018 (Integrated Stream) hereinafter referred as the Programme.
- 1.2 Degree of Master of Philosophy shall be offered in those disciplines where the Institute is offering Ph.D. programmes.
- 1.3 The degree of Master of Philosophy shall be awarded to those fulfilling the conditions as laid down under these regulations.
- 1.4 Subject to the overall direction of the Academic Council, the programme shall be administered by the School/ Department / Centre concerned.
- 1.5 These regulations shall come into force from the date of approval of the Academic Council.

2.0 DURATION

- 2.1 The duration of the Programme shall be for a minimum of three consecutive semesters and a maximum of 4 semesters.
- 2.2 In special circumstances, two extensions consisting of three months each shall be granted on payment of prescribed fees.
- 2.3 The women candidates and persons with Disability (more than 40% disability) may be allowed a relaxation of one year for M.Phil Programme. In addition, the women candidates may be provided Maternity Leave/Child Care Leave once in the entire duration of the Programme for up to 240 days.
- 2.4 Those candidates who do not either complete their course work or submit dissertation within the duration prescribed including extensions granted, the admission shall stand cancelled automatically.
- 2.5 No candidate admitted to this programme shall undertake any full time employment or join a full time course of study before completing the minimum duration prescribed.

3.0 NUMBER OF SEATS

3.1 The number of seats in each M.Phil Programme, shall be as permissible under UGC (Minimum Standard and Procedures for Awards of M.Phil/Ph.D. Degree) Regulations, 2016 and as adopted by the Academic Council of the institute.

4.0 ADMISSION PROCEDURE

- 4.1 Admission to the Integrated M.Phil. Programmes shall be conducted once in an academic year through entrance test as prescribed for this purpose.
- 4.2 The candidates seeking admission to the programme shall apply through online.
- 4.3 The Entrance Test shall consist of 50% of Research Methodology and 50% shall be discipline specific.
- 4.4 In the interview conducted for admission, the candidates are required to discuss their research interest/area through oral presentation before the selection committee concerned.
- 4.5 Those students who qualified UGC-NET (including JRF) / UGC-CSIR NET (including JRF/SLET/GATE/Teacher Fellowship holder shall be admitted directly to the Programme after an interview.

5.0 ELIGIBILITY CRITERIA

- 5.1 Candidates seeking admission to the Integrated M.Phil. Programme shall hold a Masters degree or Professional degree declared equivalent to the Masters degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7 point scale (or an equivalent grade in a point scale wherever grading systems are followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.
- 5.2 A relaxation of 5% of marks, from 55% to 50% or an equivalent relaxation of grade, shall be allowed to those belonging to SC/ST/OBC (non creamy layer)/Differently Abled and other categories of candidate as per the decision of the UGC from time to time or for those who had obtained their

Masters degree prior to Nineteenth September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

6.0 ADMISSION OF FOREIGN STUDENTS (INCLUDING NRIS)

- 6.1 In case of foreign students (including NRIs), the admission shall be online done through entrance test and interview through video conferencing.
- 6.2 The equivalence of degree possessed by foreign students / NRIs shall be settled well in advance by the Equivalence Committee.
- 6.3 The foreign students / NRIs shall be admitted within the vacancies as permissible under UGC regulations.

7.0 SUPERVISION

- 7.1 Full time regular faculty of the Institute who possess Ph.D. degree shall supervise the M.Phil., candidates.
- 7.2 The permissible number of candidates supervised by the faculty at a given point of time shall be as follows

Professor - 3 candidates Associate Professor - 2 candidates Assistant Professor - 1 candidate

- 7.3 The allocation of Research Supervisor for selected candidate shall be decided by the School/ Department / Centre concerned depending on the number of candidates per Research Supervisor, the available specialization among the Supervisor and research interests of the candidates as indicated by them at the time of interview for admission.
- 7.4 A Co-Supervisor from other departments of the Institute or from related Institutions from outside shall be allowed in inter-disciplinary areas with the approval of authorities.

8.0 PROGRAMME STRUCTURE

8.1 The M.Phil Programme can comprise of both theory and practical courses, a dissertation and viva-voce examination.

- 8.2 The course credit requirements for M.Phil Programme shall be the same as for the Ph.D. programme as given below:
- 8.3 The distribution of credits of the Programme is as follows:

Notes:

- a) Languages and Science Departments may customize course work on Quantitative Techniques.
- b) Normally all the courses shall be completed by a scholar in the first two semesters of his / her M.Phil. Programme including the seminars and term paper / topical research.
- c) Three Core courses and the supportive course on Research Methodology will be conducted during the First Semester. The course on Area of Specialization and the second supportive course will be undertaken by the candidate during the Second Semester along with Seminars and Topical Research / Term Paper.
- d) Course work will be conducted by following the semester pattern of 90 working days.
- e) Course work examinations will be conducted along with the examinations of other academic programmes.
- f) The seminar papers / topical research / term papers shall be undertaken by the research scholar on the topics related to the area of specialization.

- 8.4 Those candidates who successfully complete course work examinations in the first and second semesters shall proceed with initiation of the dissertation work in the third semester.
- 8.5 The syllabus for the Course Work and panel of examiners shall be prepared by the respective Schools / Departments / Centres with the approval of the Board of Studies.
- 8.6 A candidate who completes all the course credit requirements as in 8.3 above shall be awarded the M.Phil., degree.
- 8.7 The candidates who successfully complete the course work of the Integrated M.Phil. Programme (except dissertation as in 8.3) shall have an option to register for Ph.D. Programme in the same discipline subject to availability of vacancy and fulfilling of other norms as stipulated under UGC (Minimum Standard and Procedures for Awards of M.Phil/Ph.D. Degree) Regulations, 2016.
- 8.8 After successful completion of the Integrated M.Phil. programme, the candidate shall be eligible to register for Ph.D. programme at a later date (within three years from the completion of the programme) subject to the following conditions:
 - a) The candidate has secured CGPA the equivalent to 60% and above.
 - b) The Committee consisting of the external examiner who has evaluated the dissertation of the candidate, his/her Supervisor, Dean of the School/ Head of the Department / Director of the Centre concerned shall recommend for admission of the candidate to the Ph.D. Programme based on the merit of his/her dissertation work.
 - c) Such candidates as in 8.7 need not have to undergo the course work while registering for Ph.D. programme at any time.

9.0 EXAMINATION

9.1 The CoE will conduct the course work examinations and declare the results.

9.2 **Assessment**

Assessment of the scholars' attainment will be through an End Semester Examination (ESE) for Core and Supportive courses.

9.3 End Semester Examination (ESE)

ESE for each course will be of three hours' written examination and shall be conducted by the CoE after the completion of 90 working days in a semester.

9.4 Setting of question papers for ESE

- 9.4.1 Questions for ESE for Ph.D. coursework shall be set by the external examiners for all the courses and sent to the CoE along with the scheme of valuation.
- 9.4.2 Hard copy of the question papers shall be sent to the Dean / HoD / Director concerned and the same will be scrutinized for the coverage of syllabus, pattern of questions, correction of mistakes etc by a Question Paper Board consisting of the Dean / HoD / Director and two other Research Supervisors (on rotation) and will be forwarded to the CoE in a sealed cover.

9.5 Valuation of Answer Scripts

- 9.5.1 There shall be a single valuation by the course teacher concerned.
- 9.5.2 Appeal against ESE evaluation can be made by the candidate in the format prescribed within 10 days after the declaration of result, by paying the prescribed fee of Rs.500 per paper.

9.6 **Grading**

9.6.1 The marks scored by the candidates will be converted into Grades (G) and Grade Points (GP) as shown below:

9.6.2 A candidate has to score a minimum of B grade to get a pass.

9.7 **Seminars**

9.7.1 All the seminars are to be presented in the respective School / Department / Centre before the RQC. It shall be evaluated by a committee of faculty members who are eligible to guide Ph.D.

- programme, of whom one shall be the Dean / HoD / Director and two other faculty members on rotation, based on seniority.
- 9.7.2 Seminar paper presentation shall last for about 45 minutes followed by discussion/ question-answer session.
- 9.7.3 Seminars shall be presented every Thursday and each research scholar shall present at least one seminar in a month thereby completing all the three seminars in a semester. The seminar papers shall be evaluated by 75% for the contents and 25% for the presentation.
- 9.7.4 The mode of seminar presentation shall be powerpoint presentation along with the submission of the seminar paper.
- 9.7.5 The RQC shall grade all the three seminar paper presentation as satisfactory (S) or unsatisfactory (US) and send them to CoE. In case the seminar papers presented by the research scholar is graded unsatisfactory, then he / she has to repeat the seminar paper presentations in the next succeeding semester.

9.8. Term Paper / Topical Research

- 9.8.1 Each research scholar would submit a term paper / topical research paper at the end of the semester followed by a presentation.
- 9.8.2 The term paper / topical research paper shall be evaluated by the same committee of faculty members which evaluated the seminar. In such evaluation, 75% assessment shall be made for the contents of the term paper / topical research paper and the remaining 25% assessment will be based on the presentation.
- 9.8.3 The RQC shall grade all the term paper / topical research paper as satisfactory (S) or unsatisfactory (US) and send them to CoE. In case the term / topical research paper presented by the research scholar is graded as unsatisfactory, he/she has to resubmit the term / topical research paper in the next succeeding semester.

10.0 ATTENDANCE

10.1 All the candidates shall regularly sign the attendance register maintained in the Schools / Departments / Centres concerned during the entire period of the programme. 10.2 The progress report and attendance certificate shall be verified by the RQC periodically and the report of the RQC shall be submitted to the CoE in each Semester.

11.0 SUBMISSION OF DISSERTATION (For Candidates under 8.6)

- 11.1 The students who have completed two semesters successfully shall be allowed to submit dissertation at the end of third semester of the Programme.
- 11.2 Two copies of the dissertation along with a CD containing the full dissertation are to be submitted to the Controller of Examinations after payment of prescribed fee, if any, in this regard.
- 11.3 The candidate should have presented at least one (1) research paper in conference/seminar before the submission of dissertation for adjudication, and produce evidence for the same in the form of presentation certificate.
- 11.4 The dissertation submitted by the candidate shall be evaluated by his/her Research Supervisor and at least one external examiner.
- 11.5 The viva-voce examination shall be conducted jointly by Research Supervisor and external expert.

12.0 EXTENSION FEE

The candidates shall submit dissertation anytime after the completion of number of working days as prescribed by the Institute for second semester of the programme or within the period (s) of extension prescribed under these regulations and after the payment of fess prescribed hereunder.

- 12.1 First extension of 1-3 months after the completion of prescribed working days from the commencement of the second semester of the programme shall be granted subject to the payment of extension fee of Rs. 3000/-.
- 12.2 Second extension of 1-3 months from the date of completion of first extension shall be granted subject to the payment of extension fee of Rs.5000/-.
- 12.3 Those who do not submit their dissertations even after two extension as prescribed will have their registration cancelled.

13.0 AWARD OF DEGREE

- 13.1 Those candidates who complete all the course credit requirements including the submission of dissertation followed by successful completion of viva-voce examination shall be admitted to and conferred the degree of Master of Philosophy in the respective discipline.
- 13.2 The degree shall be awarded to the candidate, provided he/she has no disciplinary action pending against him/her and fulfilled such other conditions as prescribed under these regulations.
- 13.3 For those candidates who qualified for degree in disciplines which are interdisciplinary in nature, the Institute may issue the degree in the respective discipline in which they have registered and completed their Programme.

14.0 POWER TO REMOVE ANY DIFFICULTY

- 14.1 Notwithstanding anything contained in these regulations, any question, which is not covered by these Regulations, or any difficulty arising out of these Regulation, shall be dealt with by the Academic Council.
- 14.2 The Vice-Chancellor may in exceptional circumstances and on the recommendations of the Centre / Department / School concerned or an appropriate Committee on the merits of each individual case consider, and for reasons to be recorded, allow relaxation of any of the provisions except those prescribed in the UGC (Minimum Standard and Procedures for Awards of M.Phil/Ph.D. Degree) Regulations, 2016.

15.0 REPEAL

15.1 From the date when these Regulations come into operation, all previous regulations on the subject shall cease to be in effect, provided that this revocation shall not affect the previous batch of students.

16.0 REGULATIONS GOVERNING INTEGRATED M.Phil. LEADING TO Ph.D.

After completing the course credit requirements for the award of M.Phil degree under this scheme, the candidates who are to be admitted to the Ph.D. programme in the third semester or at a later date (within three years from the completion of the programme), shall thereafter be governed by the Ph.D. Regulations which will be in force at the time of their admission.
