**Sub: Admission of students under the Prime Minister's Special Scholarship Scheme (PMSSS) during academic year 2017-18.**

Sir/ Madam,

Ministry of Human Resource Development, Government of India has entrusted All India Council for Technical Education (AICTE), New Delhi with the task of implementation of PMSSS for students belonging to State of Jammu & Kashmir during the Academic Year 2017-18.

AICTE, New Delhi has already started counseling for admission during Academic Year 2017-18 for Jammu & Kashmir students from 30<sup>th</sup> June, 2017 at Srinagar, Jammu and Leh Counseling Centres with a direction to students to report at allotted Colleges with **10 Working Days** and they are required to upload their joining report of admission on portal of AICTE immediately otherwise the allotment of admission to the respective Institution will be treated as cancelled automatically.

In this regard, it has been reported to the Council that some of the institutions are asking students to join their own institutions and making false commitment that they will manage their scholarships. These institutions are discouraging the students to get admitted in the Colleges by AICTE and offering admission in their respective institutions by giving false promises, which has been viewed seriously by the AICTE.

It is once again reiterated that letter of admission issued by the AICTE to respective eligible / meritorious student under the PMSSS is **not transferable** and if the student is admitted in other than allotted Institutions will be treated as cancelled and no scholarship under the Scheme will be given to the student under any circumstances.

All the Universities / Colleges to which the students under PMSSS 2017-18 have been allotted admission are hereby directed to admit them for their studies without any delay for any reason. Any violation in this regard will lead to cancellation of seats of the students and can have serious repercussions.

You are, therefore, requested to facilitate the students approaching you with our letter. The details of the scheme can be seen at the AICTE website.
