Sub: Designation of Public Information Officer (PIO) and First Appellate Authority for Krishi Vigyan Kendra (KVK), Gandhigram.

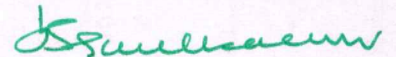
