
01. The Scholars of **M.Phil.,(Regular) PROGRAMMES IN TAMIL, ENGLISH, DEVELOPMENT SOCIOLOGY, RESEARCH AND DEVELOPMENT, ECONOMICS, CHEMISTRY and COMPUTER SCIENCE** are advised to submit their dissertation on completion of 90 working days in the second semester of the Programme. As per the M.Phil., regulations effective from 2018-2019, the Candidate should have published / presented one paper in a refereed journal or in any national conference / seminar / workshop and evidence for the same should be produced during the time of submission of Dissertation.
02. The Scholars are allowed to submit their Dissertation with two extensions of three months duration each after the completion of the second semester of the programme and the details are given below:-

Other Conditions:

03. The candidates should apply for extension (if needed) well in advance , i.e., before the start date of the required extension with prescribed fees payment.
04. The registration for M.Phil Programme will be automatically cancelled for those who do not submit their dissertations even after two extensions as prescribed above.
05. Two copies of Dissertations (First and Second copy) are to be submitted to the Examination Section.
06. All the Research Scholars should submit the "**Declaration Against Plagiarism**" along with Dissertation for further process.
07. The Dissertations must be calico bound using flexible boards. Any other binding such as spiral binding/clipped binding will not be accepted. Other General information are available in the M.Phil Regulations 2018 – 2019.
08. NO DUES CERTIFICATE obtained from the offices of the Registrar (Finance Section), Library, Hostel and the Department be produced at the time of submission of Dissertation.
