The Tamil Nadu Government introduced Electronic Clearance System (ECS) for disbursement of Postmatric Scholarship amount to the students from the academic year 2013-14 onwards.

With reference to the letters cited above, we have issued circulars by informing that all the students are advised to link their Aadhaar Number with their respective Bank Account Number for sanction and disbursement of fellowship and scholarship from the academic year 2016-17.

The District Backward Classes & Minorities Welfare officer, Dindigul organized a training programme for all the Schools/Colleges/Institutions for avoiding duplication of scholarship claims for the academic year 2016-17. They reiterate that Postmatric Scholarship amount will be sanctioned only to the students those who have linked their Aadhaar Number with their Bank Account, others are not eligible to get the scholarship for the academic year 2016-17. For any clarifications, students may contact the office of the Reservation cell during all office working hours.

All the Deans/HODs/Directors/Coordinators/Wardens are requested to advice the students in the Departments/Centre/Hostels to make arrangements for linking their Aadhaar Number along with their Bank Account by furnishing the detail in the enclosed format at the earliest.
