
2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a) The institution has acquired the land for setting up the teacher education institution.
- b) The institution has constructed the building for conducting the course on the above mentioned land.
- c) The institution has selected the Principal and Seven teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **THE GANDHIGRAM RURAL INSTITUTE-DEEMED UNIVERSITY, GANDHIGRAM-624302, DINDIGUL DISTRICT, TAMILNADU** to offer **B.Ed Integrated Course of One Year duration** under the Innovative Teacher Training Programme from the academic session **2003-04** with an annual intake of **50** students, subject to fulfillment of the following.

- a) The institution will ensure that Eight exclusive faculty members duly approved by the affiliating University are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
- b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Southern Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.

ORDER

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

**2. AND WHEREAS**, the institution, **The Gandhigram Rural Institute-Deemed University, Gandhigram, Dindigul District-624302, Tamilnadu** has by affidavit consented to come under New Regulations and sought for one basic unit in **B.Ed Integrated Programme** which require additional facilities.

**3. AND WHEREAS**, the SRC has decided to permit the institution to have one basic unit of 50 students subject to the condition that the Recognition granted shall be subject to the condition that

- i. The university should apply for two year B.Ed regular programme for 2017-18 & if the University cannot get recognition the two year B.Ed Innovative programme shall be withdrawn.
- ii. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by May 30, 2016.
- iii. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- iv. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 30.05.2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017

**5. NOW THEREFORE**, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **the Gandhigram Rural Institute-Deemed University, Gandhigram, Dindigul District-624302, Tamilnadu** for conducting **B.Ed Integrated Programme** programme of **two** years duration with an annual intake of **50** students one basic unit from the academic session **2015-16** subject to fulfilment of the conditions mentioned at 3.(i) and 4.(ii) before 30.05.2016.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

In the letter second read above, the Member Secretary, Tamil Nadu State Council for Higher Education, has forwarded the resolutions passed by the 16<sup>th</sup> Equivalence Committee meeting held on 28.06.2022 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by various Universities / Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolutions passed in the 16<sup>th</sup> Equivalence Committee meeting held on 28.06.2022, under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degrees offered by various Universities / Educational Institutions be equivalent to the similar degrees mentioned therein from the date of issuance of such degrees for the purpose of employment in Public Services and also direct that no person shall be eligible for appointment to any service, class, category or grade or any post borne on the cadre thereof, unless he possesses such special qualifications and has passed such special tests as may be prescribed in that behalf in the special rules; or possesses such other qualifications as have been declared to be higher than or equivalent to the said special qualifications or special tests, by the Government in consultation with the Committee constituted in the Government Order first read above and by the Government or by the appointing authority with the approval of the Government in other cases :-

### ORDER:-

In the letter second read above, the Member Secretary, Tamil Nadu State Council for Higher Education, has forwarded the resolutions passed by the 17<sup>th</sup> Equivalence Committee meeting held on 20.10.2022 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by various Universities / Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolutions passed in the 17<sup>th</sup> Equivalence Committee meeting held on 20.10.2022, under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degrees offered by various Universities / Educational Institutions be equivalent to the similar degrees mentioned therein from the date of issuance of such degrees for the purpose of employment in Public Services and also direct that no person shall be eligible for appointment to any service, class, category or grade or any post borne on the cadre thereof, unless he possesses such



special qualifications and has passed such special tests as may be prescribed in that behalf in the special rules; or possesses such other qualifications as have been declared to be higher than or equivalent to the said special qualifications or special tests, by the Government in consultation with the Committee constituted in the Government Order first read above and by the Government or by the appointing authority with the approval of the Government in other cases :-

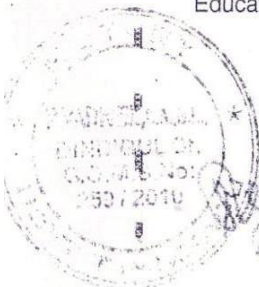

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution, **GandhiGram Rural University, GandhiGram, Dindigul-624302, Tamilnadu** has by affidavit consented to come under New Regulations and sought for one unit in **M.Ed**, which requires additional facilities

3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the fixed deposit receipts towards Endowment and Reserve Funds.

4. AND WHEREAS, it has been decided to permit the institution an intake of one unit of 50 students subject to the institution fulfilling following conditions namely,

- I. The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
- II. The institution shall create additional facilities that include (a) additional infrastructure, (b) additional funds, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

5.
