- 3. He also suggested that the Institute may have collaborative research projects with other state universities or with other development agencies
- 4. He also suggested to approach Department of Personnel and Training to have courses in 'Communication' and 'Documentation'.
- 5. Exchange of faculty members between the GRI and the Institutes like NCRI, Hyderabad, IRMA, Anand, TISS for example.

Dr. Jagroop Singh Sekhon, Professor, Department of Political Science, Guru Nanak Dev University, Punjab, suggested that the cultural and sports activities of the Institute should be strengthened.
