One of its immediate opportunities on the portal is regarding the **Viksit Bharat Young Leaders Dialogue**, i.e., the reimagined National Youth Festival, 2025. A significant highlight of the festival is the **Viksit Bharat Challenge**, comprising a quiz, an essay writing segment and development of a vision deck.
