Sub: GRI-DU – Students SC-Converted to Christian (SCC) – exempted - Tuition Fees – Eligible SC/ST Postmatric Scholarship & HESS – intimation – reg.

With reference to the letter 1<sup>st</sup> cited above, all the SC/ST/SCC students of Gandhigram Rural Institute-Deemed University, Gandhigram are exempted from paying the Tuition Fee w.e.f. the academic year 2015-16 (ref.2).

All the SC/ST/SCC students are eligible for availing Tuition Fee Concession irrespective of their parental Annual Income. All the forms received from the students through proper channel will be audited by the Local Fund Audit, and the amount will be released to the Institute by the Director, Directorate of Collegiate Education, Chennai.

Our students are paying their semester fees and the examination fees through online. In the programme, SC/ST/SCC students Semester fee will be collected without the tuition fee. Hence all the SC/ST/SCC students should submit their Tuition Fee Concession form.

The Government of Tamilnadu issues BC Community Certificate to the SC-Converted students, but they are all come under the Category of SCC Community for availing Central/State Govt. benefits in Admission and scholarship as in the case of SC/ST Students. Hence all the SCC students are eligible for availing the following scholarships:

1. SC/ST Postmatric Scholarship
2. Higher Education Special Scholarship for hostellers
3. Tuition Fee Concession.

Now, only few students have applied BC Postmatric Scholarship instead of SC Postmatric Scholarship for this year 2017-18. Hence, such students are advised to apply SC Postmatric Scholarship forms and other benefits. If there is any clarification they may contact the officer of the Reservation Cell during the working hours.

All the Deans / HODs / Directors / Course Coordinators are requested to inform their students to avail the above benefits during their course of study.
